

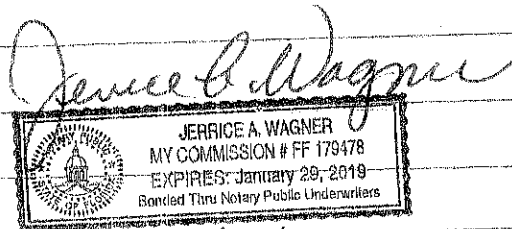

### Remarks:

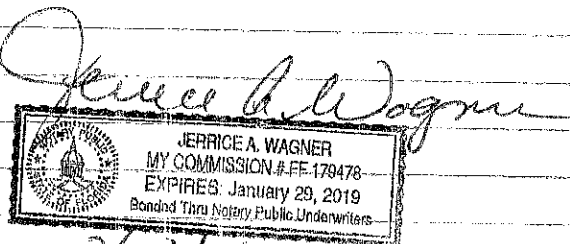



